1. CALL MEETING TO ORDER, AND ROLL CALL

Mayor Pestinger called the meeting to order at 10:00a.m., in the City Hall conference room.

2. Approval of Ordinance No. 2017-1009, Amending Ordinance No. 2017-1006, Orting Municipal Code Title 14, Chapter 1, Relating To Flood Planning Management and Flood Damage Prevention, and Ordinance No. 2017-1006.


Acting City Attorney Kim Pratt briefed the Council on the proposed ordinance. The City Council passed Ordinance No. 2017-1006 which amended Title 14 on February 22, 2017. The Ordinance was sent to FEMA and the Department of Ecology for review. The deadline to receive approval to participate in the National Flood Insurance Program is March 7th. FEMA notified the City on February 27, 2017 that they had not approved The City's Ordinance No. 2017-1006. The Ordinance which addressed changes to Title 14, was lacking key elements. Those elements were addressed in proposed Ordinance No. 2017-1009. The Council was provided the checklist from FEMA which listed the key elements that were lacking in the first ordinance. Discussion ensued between Council, Staff and the Acting City Attorney. JC Hungerford, Engineer, briefed on page 11 of the Ordinance #F-Channel Migration.

Councilmember Penner made a motion to approve and adopt Ordinance No. 2017-1009, Amending Orting Municipal Code Title 14, Chapter 1, Relating to Flood Planning Management and Flood Damage Prevention, and Ordinance No. 2017-1006. Second by Deputy Mayor Ford. Motion passed (4-0)
