1. CALL MEETING TO ORDER, PLEDGE OF ALLEGIANCE, AND ROLL CALL.

Mayor Penner called the meeting to order at 7:00pm. Councilmember Kelly led the pledge of allegiance. **Councilmembers Present:** Deputy Mayor Greg Hogan, Councilmembers Tod Gunther, John Kelly, Michelle Gehring, Joachim Pestinger, Nicola McDonald, and Scott Drennen.

2. PUBLIC COMMENTS (Council meetings are taped and the full comments may be listened too on the City's website).

Mr. Jung San Wang

Mr. Wang's comments were read into the record. They were related to the Whitehawk Extension and the proposed passage of the engineering scope and budget for a wetlands study of that project.

Bonnie Walkup

Ms. Walkup spoke about the Wang property. Ms. Walkup asked the Council to be fair and consider other options than the Wang property for the Whitehawk Extension.

3. PUBLIC HEARING

A. AB19-62- Ordinance 2019-1049, Adopting Interim Wireless Communication Facility Design Standards.

Mayor Penner opened the hearing at 7:04pm, and announced the title and read the rules for the public hearing. Charlotte Archer briefed on the proposed ordinance. The City adopted new Telecommunications Master Use Permit requirements in 2018 last year (Title 8, Chapter 8 OMC, Ord 2018-1031). This code allows for telecommunications facilities but does not provide any development standards. The City Council, following the Planning Commission's recommendations, adopted interim wireless communication facility development standards, Ord. 2019-1044. The FCC recently passed a rule that no new development standards would be accepted from local jurisdictions if they were not in place by April 14, 2019. Staff drafted a permanent wireless communication facility development standards ordinance, after feedback from staff, public and stakeholders. After a public hearing, the Planning Commission recommended approval of the ordinance on Sept. 9, 2019. The City Council reviewed this proposed ordinance on 9.18.19 at their study session. Council moved this forward for a hearing on the 25th of September. Council also received a letter from Verizon as a hearing comment which was provided to each Councilmember.

Public Comments- None

Council Comments or Questions followed.

Major points of discussion were on the following:

- The Verizon comment letter
- Pole design requirements
- Right of way placement of poles;
- Possibility of conditional use permits;
- Batch permitting.

Mayor Penner closed the hearing at 7:20pm.

Item D, adding the word identical after the word multiple, and striking the clause "provided that the application fee shall be calculated as if the applications were submitted separately". Second by Deputy Mayor Hogan. Motion passed (7-0).

4F. AB19-66- To approve the – Design and Engineering Scope and Budget from Parametrix, for the Whitehawk Extension for \$668,517.81.

Councilmember Gunther asked the Councilmembers if the letter read in earlier from Jung San Wang asking to postpone action on this item had merit. Councilmember McDonald stated that every letter has merit but whether or not they agree or move forward or approve does not invalidate the merit of the request. Councilmember Drennen stated that this item specifically addresses wetland issues, and any option has to look at the wetland impacts. He stated that at this point they are not saying this route is even feasible until they determine the extent of the wetlands in this area. Deputy Mayor Hogan stated this study is for the entire corridor. Administrator Bethune stated that this is focused on connecting at Kansas but can move around within that property depending on the conditions that are discovered. Councilmember Gehring stated that this was discussed at the study session and it lends to the argument to have the study done, in

order to see what the results are prior to moving forward on agreement on the transportation plan. This study assists Council in evaluating the alignment. Councilmember Pestinger asked if this was part of the comprehensive plan. Administrator Bethune stated that this route is already in the comprehensive plan.

Councilmember Pestinger motion to approve the Design and Engineering Scope and Budget from Parametrix, for the Whitehawk Extension for \$668,517.81. Second by Deputy Mayor Hogan. Roll Call Vote- Motion passed (5-2). The Nay votes were as follows: CM Gunther, CM McDonald
