by Chairperson Linkem. Motion carried 5-0.

Whitehawk Park City Administrator Mark Bethune reported to the Parks Advisory Board that

it was brought to the cities attention that the Whitehawk Park play structure was not sound and needed to be blocked off. He also stated that this group needs to decide what they would like to recommend to CGA on what to do.

A couple a residents from Whitehawk Development were there to find out when the play equipment is was going to be replaced. They were told that it was a process and cannot just have anything put up right away.

Some suggestions for replacement were:

• Swing Set with a baby swing

- Playground Equipment for preschool and a baby area
- Get rid of the rocks
- Covered Area

After some discussion it was discussed to look at downsizing the plans of Calistoga and using some funds from there to get something for Whitehawk Park. This recommendation will be taken to CGA to see what the councilmembers feel the Parks Advisory Board should do and then go from there.

OLD BUSINESS:

Pickleball Court

Secretary Beckie Meek reported that talking with Dylan Anderson from Risk Management is requesting that the Pickleball court be placed back from the road and the trail. He also is requesting that a net be placed up too. Chairperson Linkem asked to check with him how far from the road and also a sample of the net needed. This will be brought back to the May meeting.

Calistoga Park Master Plan Chairperson Linkem gave a brief explanation of how the Parks Advisory Board got to where it was at for the new members. He asked the new members if they have any suggestions or comments on the Calistoga Park Plans. Member Wainscott does not like the idea of a zip-line. - Play Structure
- Swings (3 bays to include ADA swings)
- Upgrade on Dog Park
- ADA Spinner
- Music Station
- Gazebo
- Benches
- Covered Areas
- Baseball Field Improvement
- Restroom
- Trails
- Turf in needed areas (play fall area) otherwise leave as grass

Motion was seconded by Member Aldrich. Motion carried 5-0.
