**ARCHITECTURAL DESIGN REVIEW:** 

ADR 2018-03 Sign Review:

DL Country Barn

Commissioners reviewed the staff report and reviewed with sign manufacturer, Valley Sign. It was clarified that the object above the sign is not a light but actually

a camera and that the light was in the eaves higher up.

Commissioner Craig moved to approve ADR 2018-03 as presented.

Commissioner Cochran seconded the motion and it carried.

Key Bank Sign Paint Valley Sign, who is contracted to repair the signage at Key Bank, explained the

repairs to be done and that the Key Bank Corporation has changed the logo to have a matte black border instead of the white. Therefore the free-standing sign and the sign on the building would have the matte black border now, with no other

changes to the existing sign design. In addition the free-standing pole would also be matte black.

Commissioner Craig move to approve the paint color change to matte black for both signs. Commissioner Cochran seconded the motion and it carried.
