1. Call to Order

Chair Gunther called the meeting to order at 4:01pm.

2. Parks Report

Jason Linkem reported that the Board has discussed the following at their last meeting:

Rehabilitation of the Basketball Court- Possible funding sources

- Citizens buying in to the project
- Go fund me
- Arts grants

The board expressed concerns about the longevity of a new paint surface. Administrator Larson said he believed it would likely last between 5-7 years. The goal of the board will be to work on funding the project before it goes back to the City Council. Chair Gunther stated he would speak to Sam Colorossi about funding projects due to his experience in this arena. Chair Gunther will also talk to citizens to see how they feel about the idea. Administrator Larson will look in to the possibility of the City doing a re-fresh of paint on the current court and provide an estimate of that cost. Chair Gunther hoped there might be a middle ground, such as the lines being painted in fluorescent colors that glow in the dark, rather than the typical paint color.

Expansion/Improvement of Skate Park

The board discussed expanding the current skate park into a park with longer concrete berms called a pump track. Jason Linkem stated that he is having a consultant visit the city to look at the current skatepark. He would also like to look in to including wheelchair accessibility. Administrator Larson suggested that these ideas should be added to the survey for the Parks Plan update. They will send the items to Emily Adams, City Planner.
