## ARCHITECTURAL DESIGN REVIEW PROCEDURE

The City of Orting has adopted an Architectural Design Ordinance for the Commercial Zone. Orting Municipal Code (OMC) 13-6-7 states: "All development in the mixed use-town centers and all commercial and public development within the city limits, is designed to be consistent with the adopted theme of "Turn of Century/Western-Victorian". All new installation, replacement, construction, renovation, remodel or alteration of, or other modifications to, buildings, miscellaneous structures and street furniture located on private property, public ways and other public property in the mixed use-town centers; all buildings, miscellaneous structures and street furniture located on private property, public ways and other public property used for commercial business or public facilities within the city limits; all multi-family buildings and cottage developments within the city limits; all stationary vendor units; and, all signs made subject to the requirements of OMC 13-6-7, are subject to architectural design review and approval."

### **PROCEDURE**

The City of Orting Planning Commission meets the first Monday of every month. The Planning Commission is a seven-member board that has the authority to review and approve, approve with conditions, or deny development/project requests. The Planning Commission's decision will be based upon the design review criteria contained in the Zoning Code. Every applicant is requested to show how the development/project meets the design review guidelines by completing the Architectural Design Review Criteria Sheet attached to this application packet.

- ❖ An Architectural Design Review Fee for this application is to be paid at the time of filing this application. This fee is **non-refundable**. Architectural Design Review Fees are shown below.
- ❖ The Planning Commission meeting will be held the first Monday of every month at 7:00 P.M.
- This application must be received <u>fourteen (14) calendar days prior</u> to the Planning Commission meeting in order to be included on the Agenda.

The following information shall be contained within the set of plans:

- 1. Vicinity map showing location of site and surrounding prominent landmarks.
- 2. Property dimension and names of adjacent roads.
- 3. Lot size and lot coverage calculations.
- 4. Location and size of proposed utility lines.
- 5. Location dimensions and nature of any proposed easements or dedications.
- 6. For commercial uses: gross floor area by use and parking calculations.
- 7. For multiple residential: location and dimensions of common open space.
- 8. Dimensioned elevation of building/structure drawn at 1/8" to 1' or a comparable scale. Elevations should show the type of exterior materials.
- 9. Location and elevations of exterior lighting for buildings and parking areas.
- 10. Location and elevations of dumpster screens.
- 11. Color samples for buildings, structures and accessory structures with a notation explaining where and how these colors will be used.
