Good evening,

I regret being unable to attend in person. It came to my attention that the Orting Recovery Café is proposing to build an emergency parking lot to create a safe space for homeless individuals. I do not believe that this is in the best interest of the community, and I believe it puts the safety of transients over the safety of our citizens in the community.

- 1. There is a clear connection between homelessness and substance abuse. This is especially concerning given the national fentanyl crisis and the rise in substance abuse disorder amongst young people. I understand the Recovery Café has a policy against illegal substance use, but will the Recovery Café consider it "compassionate" to remove violators and will there be inspections of vehicles to ensure there is no drug paraphernalia associated with the lot? We don't needs our kids stumbling upon used needles or fentanyl pipes.
- 2. The is a strong correlation between homeless encampments, transient living areas, etc. and violent crime. The Orting Police Dept. is already understaffed to the degree that they cannot provide a full-time school resource officer to each of the OSD campuses. It is therefore unreasonable to presume that they can be the security service for the emergency parking lot.
- 3. The proposed location of the emergency parking lot is inside of an existing subdivision and adjacent to the downtown park. It is located approximately a half a mile from Orting Elementary School. The community would literally be inviting transients to camp within a mile of our youngest and most vulnerable community members. Many of our community's children might have to walk by this parking lot on their way to/from school, and there is no guarantee that these transients are not performing lewd acts in/around their vehicles or engaging in the use of illicit substances. Just because there are rules against such acts does not mean that there is persistent surveillance on the campers and that such policies will be enforced. Would the Recovery Café consider it "compassionate" to evict a transient who does not abide by the rules/policies?
- 4. The state already has lax laws on pollution as evidenced by the obscene amount of trash in our city's parks and along our state's highways, and "the environmental impacts of homeless encampments...are not sustainable." Does the Recovery Café have a maximum stay length and will the Recovery Café consider it "compassionate" to evict a transient who overstays the maximum limit? The longer homeless transients remain in an area, the more entrenched and entitled they become and with that entrenchment comes the risk of rodents and other vermin.
- 5. Transient areas or homeless encampments are bad for business, and this proposal puts the emergency parking lot right next to the heart of downtown. "Neighborhoods that are frequented by people experiencing homelessness are perceived as dangerous, dirty areas to avoid, which can hurt

businesses in the area. The unavailability of public restrooms creates a mess, and some unsheltered people cause thousands of dollars in property damage. Ultimately this affects common area charges, property owners and tenants. When unsheltered people buy a light rail ticket and just ride to get out of the heat, they may deter others from riding, and when they congregate at businesses, this may deter patrons."[v]

Overall, the proposal does not seem like the right decision for the citizens of Orting or the beautification and betterment of our community. It is a band-aid that fails to address the root cause of the homeless crisis, which includes untreated mental illness, lack of mental institutions, drug and alcohol addiction, lack of affordable housing, and overcrowded prison systems that are unable to hold drug offenders.

There has been a lot of talk in the community for safe parking. It has been sickening to hear the unfair, inaccurate depictions of people who are unhoused. The assumptions of drug use, criminal activity, and filth. Statistically we are more at risk to be a victim of a crime from housed white men then we are people who are unhoused, and yet I have heard nothing about what the city is going to do about the risk we face each day from "those people" but yet we hear about it consistently about people who are unhoused.

The rumor mill has been running and the current rumor around town is that instead of letting a local business do safe parking, a business that states that they have the staff, space, training, and money to successfully provide a safe place to sleep, that the city of orting is pushing to have churches do this. THIS IS INSANE!!!!! If you guys are truly listening to the concerns of the community (even though most of these concerns are unwarranted) you would see that having churches do this is absolutely stupid. Churches don't have the staff, the training, the money, the security or the access to resources to help these families transition into a more permanent housing situation. They do not have staff there most of the time. They do not have a secure location for these families. Who are more at risk of crimes being committed on them by housed individuals, than they are likely to commit crimes.

The housed residents of Orting have stigmatized and demonized people who are struggling, you all have the opportunity to give people who are struggling the opportunity to access the support they need to stabilize, and you are putting every roadblock in the way to help them. It is sickening. I thought you were supposed to represent all of Ortings citizens, not just the citizens that aren't faced with

challenges, probably most of you can't even comprehend. I hope that you guys will prioritize the wellbeing of all of Ortings citizens, not just the fortunate ones.
