2 MONTHS EARLIER ? THE CITY SAYING MY VEHICLES WERE ON CITY PROPERTY AND TO HAVE US MOVE THEM AS TOLD TO DO AND THEN THE CITY HAVE THEM TOWED WHILE INVOLVING THE ENTIRE ORTING POLICE DEPARTMENT ? TOW OPERATORS, CITY OFFICIALS AND LETS NOT FORGET THE LETTER TO MY LAND-LORD STATING EITHER HE GUILTS ME OR HE FACES FINES EVERY DAY WE REMAIN RESIDENTS AT HIS PROPERTY, SO HERE'S HOW ITS GOING TO GO, FIRSTOFF THE PROPERTY OF THE FARM THAT WAS SOLD NEEDS TO BE ABATED, THAT IS A PERIOD THING, THE ORDINANCE STATING HUNOW REMAINS FOUND DONT NEED TO BE REPORTED TO ME ? NATIVE AUTHORITIES GETS STRICKEN, I WANT A TEEN CENTER BUILT WHERE THE FARM ONCE STOOD, AND THAT TEEN CENTER TO BE THE NAMES OF MY CHILDREN THAT ORTING DID NOTHING TO STOP THEIR DEATHS, I WANT ORTING TO OWN UP TO AND TAKE RESPONSIBILITY OF THE POLICE OFFICERS THEY HAVE BEEN FIRED, AND TURNER & CREIF TO BOTH BE INVESTIGATED BY THE PROPER AGENCIES. THE CITIES GOVERNMENT SUCH AS MAYOR & ADMINISTRATOR IMMEDIATELY FIRED & A WHOLE NEW VOTE FOR CITY COUNCIL TO CLEAN THE SWAMP OF THOSE CORRUPT POLITICIANS WORKING FOR ORTING, AND AS FOR MYSELF I WANT TO NOT ONLY BE RELEASED IMMEDIATELY BY THE END OF THE DAY BUT I WANT COMPENSATION FOR MY TIME INCARCERATED FALSELY, MY VEHICLES STOLEN REPLACED IMMEDIATELY, APOLOGIES BY THOSE WHO WROTEFULLY ①

HAVE VIOLATED MY RIGHTS BOTH CIVILY AND CONSTITUTIONALLY. MY REPUTATION RESTORED AND PUBLIC APOLOGIES BY THE MAYOR & CITY OFFICIALS WHO HAVE TARNISHED MY REPUTATIONS AROUND THE COMMUNITY BY THEIR LIES AND CORRUPTION. I WILL NOT SETTLE FOR LESS THAN 10 MILLION IN CASH FOR THE PAIN & SUFFERING MY FAMILY HAS ENDURED AND EVERY DAY THAT GOES BY NOT MEETING OR AT LEAST ATTEMPTING TO MEET A HAPPY MEDIUM OF MY DEMANDS WILL ONLY MAKE THAT NUMBER CLIMB. NOW IF BY CHANCE ORTING DOESN'T FEEL THE OWE APOLOGIES? TO BUILD A TREN CENTER TO MY LIKINGS FOR THE CHILDREN OF ORTING THE CITY CAN ALSO JUST PAY ME OUTRIGHT 25 MILLION AT WHICH TIME I WILL HIRE SOMEONE TO BUILD IT MYSELF AND ALSO HIRE AN ATTORNEY WHO WILL SUE ORTING SO BAD THAT ORTING WILL BE FORCED TO BE ANNEXED AND ALL CITY JOBS WILL NO LONGER EXIST BUT THEY WILL BE PIERCE COUNTY JOBS. I HOPE THIS LETTER FINDS YOU AT A SHOCK AND HAS YOUR MOUTHS HITTING THE FLOOR. SINCE I RESEARCHED IVE BEEN ABLE TO FIND OVER 20 LAWS BROKEN BY ORTING THAT OVER HALF OF THEM ARE PUNISHABLE BY IMPRISONMENT, FROM THE PROSECUTING ATTORNEY OFFERING BUBLES TO THE FALSE REASONING BEHIND MY RIGHT TO AN ATTORNEY. WORDS SUCH AS I DONT QUALIFY FOR AN ATTORNEY BECAUSE IM A WELDER BY TRADE WHEN IVE ONLY EVER WELDED 3 TIMES IN MY LIFE VIOLATES MY RIGHTS TO REPRESENTATION. NOT TO MENTION ARRESTING ME AFTER MS. SCHMIDT ADMITS TO SINK

me in the forehead with something other than her hands
intentionally intending to cause harm & while I had
our 9 month old daughter in my arms for feeding my
daughter a pacifier to help reduce her fever due to teething
this is an atrocity & I demand my release and all
charges dropped immediately (as is now!!!) and that
my demands be met on a timely manner as my health
is not doing so well & ~~if~~ any further time locked up
& restrained from my daughter & home is considered
cruel & unusual. I'm being held against my will &
although there was no abuse dishes out to Ms Schmidt
the day she assaulted me in our daughter one foot
away from where she struck me in my head by God
knows what she struck me with that created the
golfball sized lump over my eye & forced my immediate
fear for myself and my daughters safety to put my arm
up to defend a second strike. Ms. Schmidt admitted this
and admitted to the 911 operator she wasn't hurt over 5 times
that she just wanted to take our daughter to her moms
house at 4 am after assaulting me & which I refused
allowing her to take our daughter due to her mind
and physical characteristics which to any normal
person showed a psychiatric melt down due to
post partum depression. I am serious as heart
attack that if my demands aren't met now I will
begin sending letters ~~and~~ to the media & the
courts ombudsman and disciplinary offices until
orting is held up so much red tape that every employee
