**A RESOLUTION OF THE CITY OF ORTING, WASHINGTON,
DECLARING CERTAIN WASTEWATER PLANT AERATORS AS
SURPLUS PROPERTY AND AUTHORIZING DISPOSAL**

WHEREAS, it has been determined that the City has no further use of certain aerators for treatment of wastewater at our wastewater treatment plant due to a previous change in design; and that such items are surplus to the needs of the City; and

WHEREAS, RCW 39.33.010 allows for intergovernmental sale of property; and

WHEREAS, at time of sale or disposal of the surplus item(s), any monies derived from the same will be allocated back to the appropriate department; and

WHEREAS, the City Administrator will oversee the transfer of these item(s);

**NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ORTING,
WASHINGTON, DOES RESOLVE AS FOLLOWS:**



NOW THEREFORE, IT IS HEREBY DECLARED, for and in consideration of the sum of One Dollar (\$1.00) and other good and sufficient consideration, receipt whereof is hereby acknowledged, the undersigned Seller(s) City of Orting, Washington, a municipal corporation do(es) hereby convey, set over, assign, transfer and sell to the Purchaser(s) City of Vader, Washington, a municipal corporation, the surplus treatment plant aerator equipment as described as follows 3 Floating Aerators; model 1010-SF-1 Aqua-Lator Aerators – 10 HP motors, manufactured by Aerators Inc. Roscoe, Illinios.

Seller warrants that he/she, they, it, is/are the sole owner(s) of all the property above described and has/have full power to convey all rights herein conveyed.

Buyer agrees to hold the City of Orting harmless from any and all claims which might result from execution of this document.


