1. CALL MEETING TO ORDER, PLEDGE OF ALLEGIANCE, AND ROLL CALL.

Mayor Penner called the meeting to order at 7:01pm. Councilmember Williams led the pledge of allegiance. **Councilmembers Present**: Deputy Mayor Greg Hogan, Councilmembers Tod Gunther, John Kelly, John Williams, Gregg Bradshaw, and Scott Drennen.

Absent: Tony Belot (Councilmember Belot arrived at 7:32pm)

Staff Present: Mark Bethune, City Administrator, Jane Montgomery, City Clerk, Scott Larson, Treasurer/Assistant City Administrator, Charlotte Archer, City Attorney, JC Hungerford, Engineer.

Councilmember Drennen made a motion to excuse Councilmember Belot. Second by Councilmember Kelly. Motion passed (6-0)

2. PROCLAMATION

A. AB20-41- Resolution No. 2020-12, Ratifying Mayor's Proclamation of Emergency Proclamation of Emergency.

Charlotte Archer briefed on the Proclamation that the Mayor issued on March 13th, 2020, regarding the COVID-19 public health pandemic. The proposed resolution would ratify the Mayor's Proclamation of Emergency, confirming the existence of this emergency, and authorizing the Mayor to take the actions authorized under state statute in response to the emergency.

Deputy Mayor Hogan made a motion to Adopt Resolution No. 2020-12, Ratifying the Mayor's Proclamation of Emergency dated March 13, 2020. Second By Councilmember Kelly. Motion passed (6-0).

3. DISCUSSION

A. COVID19 Updates.

Mayor Penner briefed the City Council on updates since the last briefing:

- To date, there had not been any COVID19 related deaths in Orting. There was one death in Buckley.
- The Mayor spoke to citizens who reached out to him about access to internet out on Patterson Road. A meeting was set up with Comcast, Century link, and the School District to discuss the issue for those in the Orting Community that do not live in City limits.
- Council IPads were ordered, and should be here prior to the next meeting;
- The Mayor asked the Public Works crew to put up holiday lights to provide relief to citizens giving them something to smile about;
- The Governor currently has set May 4th, 2020 as the day that social isolation is supposed to end. The Mayor suspects that that date may be pushed out well in to the summer.

Council questions followed relating to issues arising from COVID19.

4. DEPARTMENT UPDATES.

The following staff members provided updates: Treasurer Larson, and Mark Bethune. (Verbatim tape may be accessed on the City website).

5. PUBLIC COMMENTS- No comments were sent to the City Clerk.

Councilmember Kelly made a motion to approve Consent Agenda with the change of Melody Koening to President of the Whitehawk group. Second By Councilmember Drennen. Motion passed (7-0).

7. NEW BUSINESS

A. AB20-39- Ordinance No. 2020-1060 Pertaining to Enforcement of Emergency Orders.

City Attorney Archer briefed that he proposed Ordinance was drafted by her and Aaron Walls the City Prosecutor and would :

- Adopt by reference RCW 4306.220, which makes the violation of any proclamation by the governor during a state of emergency a misdemeanor/gross misdemeanor in Orting;
- Adopt by reference RCW 70.05.120, which makes the violation of any rule or order of the Tacoma/Pierce Public Health Official (or any local health officer set out in the RCW) a misdemeanor/gross misdemeanor;
- Codify the Mayor's authority under state law to proclaim an emergency, and makes the violation of the Mayor's proclamation or any emergency management regulation adopted a misdemeanor/gross misdemeanor.

Council discussion followed. Main objections were centered on whether or not the Council wanted to follow state law relating to any violation of the governor's order, and in effect create a criminal record for a citizen. Council determined that they would like the ordinance to be reviewed at a future study session. Council would like to see if there is something that can be done to respect the Emergency order, yet not criminalize violations of the orders.

Councilmember Bradshaw made a motion to move this to a study session. Second By Councilmember Williams. Motion passed (7-0).

B. AB20-40- PBS Engineering and Environmental Amendment No. 1.

Administrator Bethune briefed that the Council approved PBS Engineering as the most qualified vendor per an RFP, to handle contamination issues at the new City Hall site. Those duties were performed and they developed a plan to handle future issues. They are at the final stage now and the Tacoma Pierce County Health Department determined that a groundwater monitoring program is necessary to achieve site closure for the contaminated soil on the new municipal facility property. Under the attached scope of work, PBS would install three groundwater wells and provide four quarterly Groundwater Monitoring Events. This is a step necessary to enter in to the voluntary closure program with the Department of Ecology.

Councilmember Drennen made a motion to authorize the Mayor to sign a contract with PBS Engineering and Environmental Inc. in the amount of \$16,260 for the installation and monitoring of Ground water wells at the new City Hall site. Second By Councilmember Bradshaw. Motion passed (7-0).

B. AB20-39- Ordinance No. 2020-1060- Pertaining to Enforcement of Emergency Orders.

Charlotte Archer briefed on the proposed ordinance which would adopt by City code, provisions that would deal with violations of the Governor's order, and the Mayor's proclamation. Examples of how other cities are approaching this were cited. If Council were to adopt by reference the statute, violations would have to be a misdemeanor or gross misdemeanor, and they would not be allowed to deviate from these penalties. Chief Gard provided insight as to how this would work from an operational standpoint, and stated that he did not have any compliance issues at this time. Possible options were laid out by the City Attorney. Council discussion followed relating to possible options to pursue. Based on Council discussion, Mayor Penner suggested option #3 with a civil infraction, to keep the authority within the City of Orting.

Council by consensus; would like to bring this back to the next meeting and they proposed:

- No adoption by reference of RCW 43.06.220, which would make a violation of the Governor's order a misdemeanor or gross misdemeanor;
- Make amendments to OMC Chapter 1-8, pertaining to the Mayor's authority to issue a Proclamation of Civil Emergency, including a penalty provision for violations of the Mayor's Proclamation starting with a civil infraction and use of a graduated approach after the first offense.

C. COVID 19 DISCUSSION ITEMS

Mayor Penner stated he has a growing concern about the Governor's State of Emergency Proclamation and the date that the Governor will declare as the gradual re-opening of some of the stay at home and business restrictions. He stated that the Governor seems to be signaling that he may extend the order beyond May 4th, 2020. The Mayor stated there may come a time when the local position may deviate in part from the Governor's orders. Likely in a month or two, if the Emergency order persists, he may be bringing forward a local plan that allows the City to do normal business, the most basic items that make the City better. Council shared their individual opinions on the matter relating to how the City might proceed in the future.

Councilmember Gunther mentioned that other Cities have been doing celebrations for first responders. He would like to put up lights in the bell tower. Director Reed informed Council that at the direction of the Mayor his crew have already put blue lights up on the bell in the bell tower and

tomorrow they will be putting blue lights across the highway on Main Street. Mayor Penner stated that he was pleased with the work that had been done by the Public Works crew through donations provided by Community members.

SUMMARY STATEMENT:

Background: The U.S. President, Governor of Washington, County Executive, local public health officials and Mayor have all issued proclamations and other orders related to the COVID-19 pandemic. On Monday, March 30, 2020, Governor Inslee issued guidance to local law enforcement regarding enforcement of these orders. Violations of the Governor's Order and the orders of local public health officials are classified as misdemeanors/gross misdemeanors under state law, but local law enforcement has limited enforcement ability to charge these unless the City adopts the relevant RCWs by reference in its code. Similarly, the Mayor is authorized under state law to proclaim a state of emergency, but currently there is no provision in the Orting Municipal Code pertaining to enforcement of rules adopted by the Mayor and City Council to aid in combating this public health emergency.

Currently and moving forward the primary goal as it relates to enforcement and gaining compliance with the Governor's Order is <u>education</u>. However, in the event of an egregious, repeat offender, tools are necessary to meet the Mayor's directive to take action against chronic, flagrant violations that present a danger to the public health and safety.

What other cities in Washington are doing: Some Washington cities had regulations in their municipal codes to address enforcement of an order issued during a proclaimed emergency, prior to the current emergency. Here are a few examples:

- City of Buckley (Buckley Municipal Code 2.96.170), City of Sumner (Sumner Municipal Code 2.76.110), and City of Monroe (Monroe Municipal Code 2.60.13): the violation of an order issued by an emergency management official during a declared emergency is a misdemeanor or gross misdemeanor, fine not to exceed \$1,000 and not more than 90 days in jail (or both).
- City of Puyallup (Puyallup Municipal Code 2.31.130): violation of an order issued by an emergency management official during a declared emergency is a misdemeanor punished by 90 days in jail or

- \$1,000 fine, or both; repeat offenses are gross misdemeanor punished by one year in jail and \$5,000 fine, or both.
- City of Yelm (Yelm Municipal code 2.28.100): violation of an order issued by an emergency management official during a declared emergency is a misdemeanor and a fine of \$250.
- City of Othello: Othello Municipal Code Chapter 2.62 authorizes the Mayor to issue a Proclamation of civil emergency and associated regulations, including a curfew and the closure of businesses. A violation of the order is a C-1 civil infraction (penalty of \$1,000).

Cities and agencies in Washington without existing code provisions are taking different approaches to enforcement. Here are a few examples:

- City of Kirkland Adopted Ordinance No. 4721, making the knowing violation of a lawful order by a
 federal, state, county or local public officer issued in response to the declared emergency a
 misdemeanor. This Ordinance, and the underlying code change, expires on April 30, 2020 (unless
 extended by the Council).
- Spokane Health Authority For businesses refusing to comply and operating in contravention of the Governor's Order and after multiple attempts at voluntary compliance, the agency is seeking a Temporary Restraining Order to close the business.

Comments from Chief Gard and Lieutenant Gabreluk:

We do need to take every step within reasonable parameters to keep the public safe. The common protocol for a law enforcement response protocol is to do our best to educate and remind. If we encounter or respond to repetitive violators who are unwilling to alter their behavior, we can take a formal report, and then forward it to our city prosecutor for a charging review. Note: the prosecutor indicated that these would have to be referred out because the municipal court does not have jurisdiction.

Proposed Ordinance:

Based on feedback from the Council during the Study Session on 4/15/20, the Ordinance now includes the following:

- No adoption by reference of RCW 43.06.220, making a violation of the Governor's Order a misdemeanor;
- Amendments to OMC Chapter 1-8, pertaining to the Mayor's authority to issue a Proclamation of Civil Emergency, including a penalty provision for violations of the Mayor's Proclamation and related orders setting the penalty as follows: first violation = class 4 civil infraction (\$60 fine, plus statutory assessments); second violation = class 3 civil infraction (\$120 fine, plus statutory assessments); third and subsequent violations = misdemeanor (\$1,000 fine / 90 days in jail).

RECOMMENDED MOTION: To adopt Ordinance No. 2020-1060, Amending OMC Chapter 1-8 Pertaining to Emergency Management.

CITY OF ORTING WASHINGTON ORDINANCE NO. 2020-1060

AN **ORDINANCE OF** THE **CITY OF** ORTING, WASHINGTON, RELATING TO **EMERGENCY** MANAGEMENT, ADOPTING NEW OMC 6-1B-19 **ENFORCEMENT OF EMERGENCY PROCLAMATIONS:** AMENDING OMC CHAPTER 1-8 FOR EMERGENCY MANAGEMENT: **DECLARING** AN**EMERGENCY:** PROVIDING FOR SEVERABILITY; ESTABLISHING AN

IMMEDIATE EFFECTIVE DATE

WHEREAS, RCW 43.06.220 provides that the Governor of the State of Washington may issue orders by proclamation following declaration of a state of emergency, and that "[a]ny person violating any provision of an order issued by the governor under this section is guilty of a gross misdemeanor[;]" a

WHEREAS, the Washington State Governor issued Pproclamation 20-05 on February 29, 2020 declaring that the worldwide outbreak of coronavirus disease 2019 (COVID-19) created a State of Emergency in all Washington Counties; and

WHEREAS, the Washington State Governor issued subsequent proclamations to curtail conduct that spreads the disease; that are enforceable through RCW 43.06.220; and

WHEREAS, RCW 70.05.120 establishes a penalty for violations of chapters 70.05, 70.24 and 70.46 RCW, pertaining to orders and rules issued by the local board of health or local health official for the prevention, suppression and control of dangerous contagious and infectious diseases; and

WHEREAS, the Washington Supreme Court held in *Auburn v. Gauntt*, 174 Wn.2d 321, 274 P.3d 1033 (2012) that cities can only prosecute state statutes that are adopted or incorporated into its municipal code; and

WHEREAS, the Mayor likewise has authority to declare a proclamation of emergency due to a public health crisis or other civil emergency, and seek ratification of that proclamation by the City Council, pursuant to Chapter 38.52 RCW; and

——WHEREAS, the Mayor issued a Proclamation of Local Emergency on March 13, 2020, pertaining to the spread of the novel coronavirus known and COVID-19, pursuant to authority vested in him by Chapter 38.52 RCW and the City's Emergency Management Plan; and

WHEREAS, the City Council ratified the Mayor's Proclamation at its regular meeting of April 8, 2020; and

WHEREAS, the City Council desires to clarify the authority for and impact of a proclamation of emergency by the Governor, Mayor and public health officials, and set out penalties for violations of same; and

WHEREAS, the City Council finds that adoption of new OMC 6-1B-15 and the amendments to OMC Chapter 1-8 as set out herein is appropriate and necessary to aid in the protection and preservation of public health, safety and welfare; and

WHEREAS, the Mayor issued a Proclamation of Local Emergency on March 13, 2020, pertaining to the spread of the novel coronavirus known and COVID-19; and

WHEREAS, the Council finds that the COVID-19 pandemic poses an emergency to the public health and safety, and warrants immediate action by the Council to aid the City to prevent the further dissemination of the virus and to combat its impacts;

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ORTING, WASHINGTON, DO ORDAIN AS FOLLOWS:

Section 1. OMC Chapter 6-1B-19, Enacted. New Section 6-1B-19 of the Orting Municipal Code, titled "Enforcement of Emergency Proclamations" is hereby enacted to read as follows:

6-1B-19 ENFORCEMENT OF EMERGENCY PROCLAMATIONS.

A. RCW 43.06.220 is adopted by reference as if set forth in full in this chapter. The penalties for violation of any proclamation issued by the governor during a state of emergency shall be as set forth in Section 6-1A-14.

B. RCW 70.05.120 is adopted by reference as if set forth in full in this chapter. The penalties for violation of any of the requirements therein, including but not limited to any directive from the by the local board of health or local health officer or administrative officer or state board of health, shall be as set forth in Section 6-1A-14.

Section 2. OMC Chapter 1-8, Emergency Services Department, Amended. Chapter 1-8 of the Orting Municipal Code is hereby amended to read as follows:

EMERGENCY MANAGEMENTSERVICES DEPARTMENT

1-8-1: Creation; Purpose

1-8-2: Director of Emergency Services

1-8-3: Copy of Ordinance to State

1-8-4: Proclamation of Emergency

1-8-1: CREATION; PURPOSE:

There is hereby created the Department of Emergency Services. The purpose of said Department shall be to formulate such rules and regulations as are necessary to help the City prepare for and deal with an emergency or disaster of the magnitude referred to in the preamble of Ordinance 557 codified in this Chapter.

1-8-2: DIRECTOR OF EMERGENCY SERVICES:

- —A. Position Created; Appointment: There is hereby created the position of the Director of the Emergency Services Department. The Director shall be appointed by the Mayor subject to confirmation by the City Council.
- —B. Duties And Responsibilities: The Director of the Emergency Services Department shall be directly responsible to the Mayor and said Director shall be responsible for the organization, administration, and operation of the Department of Emergency Services. The Director of the Department of Emergency Services shall promulgate such rules and regulations as are necessary in order to prepare the City for dealing with an emergency or disaster as described in the preamble to Ordinance 557 codified in this Chapter. All rules and regulations so promulgated shall be approved by the Mayor prior to becoming effective.

1-8-3: COPY OF ORDINANCE TO STATE:

A certified copy of Ordinance 557 codified in this Chapter, and all subsequent Ordinances amending this Chapter, shall be sent to the Director of the Washington State Emergency Services Council and the Director of the Emergency Services Department shall coordinate his efforts with that of the Director of the Washington State Emergency Services Council. (1973 Code § 2.36.030)

1-8-4: PROCLAMATION OF EMERGENCY:

A. Proclamation by Mayor. Whenever an emergency as defined herein, or the imminent threat thereof, occurs in the City and results in, or threatens to result in the death or injury of persons or the destruction of or damage to property to such extent as to require, in the judgment of the Mayor, extraordinary measures to protect the public peace, safety and welfare, the Mayor may proclaim in writing the existence of a civil emergency. In the absence of the Mayor, the Deputy Mayor may declare an emergency and issue orders, and in the absence of the Mayor Pro Tem, the City Manager may declare an emergency and issue orders. The authority granted to the Mayor in this chapter is in addition to and not in limitation of other policies allowing the Mayor to declare an emergency and take action necessary to deal with such emergency, including but not limited to those powers set forth in Chapter 38.52 RCW.

For the purposes of this chapter an emergency shall mean:

- (1) A riot, unlawful assembly, insurrection, enemy attack, sabotage, or other hostile action; or
- (2) A natural or human-caused disaster, including fire, flood, storm, explosion, earthquake, volcanic disturbance or other natural cause; or

- (3) An event or set of circumstances that demands immediate action to preserve public health, protect life, protect public property, or to provide relief to any stricken neighborhood overtaken by such occurrences;
 - (4) Any emergency or disaster as defined by RCW 38.52.010.

Proclamations of civil emergencies issued by the Mayor shall as soon as practicable be filed with the City Clerk and presented to the City Council for ratification and confirmation, modification or rejection. Proclamations which are rejected shall, after vote, be void. Proclamations shall be considered in full force and effect until the City Council shall act to ratify.

B. In addition to or as an alternative to those emergency powers prescribed by this chapter upon the declaration of a civil emergency upon proclamation of a state of emergency or disaster by the Governor or County Executive pursuant to chapter 43.06 RCW and chapter 38.52 RCW, the Mayor shall have the authority to exercise authority all emergency powers and take action necessary to deal with such emergency, including but not limited to those powers set forth in Chapter 38.52 RCW.

1-8-5: VIOLATION; PENALTY:

A. It shall be a violation of this chapter to:

- 1. Willfully obstruct, hinder, or delay any member of the emergency management organization in the enforcement of any lawful rule or regulation issued pursuant to this chapter or in the performance of any duty imposed upon such member by virtue of this chapter;
- 2. Perform any act forbidden by any lawful rule or regulation issued pursuant to this chapter if such act is of such a nature as to imperil the lives or property of inhabitants of this city, or to prevent, hinder, or delay the defense of protection thereof; or
- 3. Wear, carry or display, without authority, any means of identification specified by the emergency management agency of the city.
- B. Violations of a declaration of civil emergency issued pursuant to this chapter or of a subsequent emergency order issued pursuant this chapter, or any other order or directive given by a law enforcement officer or designated emergency services personnel pursuant to authority of such declaration or orders, shall be punishable pursuant to under OMC 1-4-1 and OMC 1-4-2 as follows:
 - 1. The first violation within a one-year period shall constitute a class four (4) civil infraction, punishable by a fine not to exceed sixty dollars (\$60.00), not including statutory assessments.
 - 2. A second violation within a one-year period shall constitute a class three (3) civil infraction, punishable by a fine not to exceed one hundred twenty dollars (\$120.00), not including statutory assessments..
 - 3. A third violation and each violation thereafter within a one-year period shall be a misdemeanor, punishable by a fine not to exceed one thousand dollars (\$1,000.00) or imprisonment for up to ninety (90) days in jail, or by both such fine and

imprisonment. [CLASS X CIVIL INFRACTION, PER OMC 1-4-2(G)] [MISDEMEANOR]

1-8-6: **IMMUNITY**:

There shall be no liability on the part of any person, partnership, corporation, the state of Washington or any political subdivision thereof who owns or maintains any buildings or premises that have been designated by the Director as a disaster shelter for any injuries sustained by any person while in or upon said building or premises as a result of the condition of said building or premises or as a result of any act or omission, or in any way arising from the designation of such premises as a shelter, provided such person has entered, gone upon or into said building or premises for the purpose of seeking refuge therein during a disaster; provided further, however, that this section shall not apply to the willful acts of such owner or occupant or his or her servants, agents, or employees. This section shall also apply to any practice drill authorized pursuant to this chapter.

Section 23. Declaration of Emergency. Pursuant to RCW 35A.12.130 and RCW 35A.13.190, the City Council finds that this Ordinance is a public emergency ordinance necessary for the protection of the public health, public safety, public property, or public peace, and shall take effect and be in full force immediately upon its adoption. Pursuant to *Matson v. Clark County Board of Commissioners*, 79 Wn. App. 641, 904 P.2d 317 (1995), underlying facts necessary to support this emergency declaration are included in the recitals set forth above, which are adopted by reference.

<u>Section 34.</u> <u>Severability.</u> Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.

<u>Section 45.</u> <u>Codification</u>. The City Council authorizes the City Clerk to correct any non-substantive errors herein, codify the above, and publish the amended code.

<u>Section 56.</u> <u>Effective Date.</u> This Ordinance shall take effect immediately and shall be published in the official newspaper of the City.

Violations of a declaration of civil emergency issued pursuant to this chapter or of a subsequent emergency order issued pursuant this chapter, or any other order or directive given by a law enforcement officer or designated emergency services personnel pursuant to authority of such declaration or orders, shall be punishable pursuant to under OMC 1-4-1 and OMC 1-4-2 as follows:

- 1. The first violation within a one-year period shall constitute a class four (4) civil infraction, punishable by a fine not to exceed sixty dollars (\$60.00), not including statutory assessments.
- 2. A second violation within a one-year period shall constitute a class three (3) civil infraction, punishable by a fine not to exceed one hundred twenty dollars (\$120.00), not including statutory assessments..
- 3. A third violation and each violation thereafter within a one-year period shall be a misdemeanor, punishable by a fine not to exceed one thousand dollars (\$1,000.00) or imprisonment for up to ninety (90) days in jail, or by both such fine and imprisonment.

1-8-6: IMMUNITY:

There shall be no liability on the part of any person, partnership, corporation, the state of Washington or any political subdivision thereof who owns or maintains any buildings or premises that have been designated by the Director as a disaster shelter for any injuries sustained by any person while in or upon said building or premises as a result of the condition of said building or premises or as a result of any act or omission, or in any way arising from the designation of such premises as a shelter, provided such person has entered, gone upon or into said building or premises for the purpose of seeking refuge therein during a disaster; provided further, however, that this section shall not apply to the willful acts of such owner or occupant or his or her servants, agents, or employees. This section shall also apply to any practice drill authorized pursuant to this chapter.

- Section 2. Declaration of Emergency. Pursuant to RCW 35A.12.130 and RCW 35A.13.190, the City Council finds that this Ordinance is a public emergency ordinance necessary for the protection of the public health, public safety, public property, or public peace, and shall take effect and be in full force immediately upon its adoption. Pursuant to *Matson v. Clark County Board of Commissioners*, 79 Wn. App. 641, 904 P.2d 317 (1995), underlying facts necessary to support this emergency declaration are included in the recitals set forth above, which are adopted by reference.
- <u>Section 3.</u> <u>Severability.</u> Should any section, paragraph, sentence, clause or phrase of this Ordinance, or its application to any person or circumstance, be declared unconstitutional or otherwise invalid for any reason, or should any portion of this Ordinance be pre-empted by state or federal law or regulation, such decision or pre-emption shall not affect the validity of the remaining portions of this Ordinance or its application to other persons or circumstances.
- **Section 4. Codification**. The City Council authorizes the City Clerk to correct any non-substantive errors herein, codify the above, and publish the amended code.
- <u>Section 5.</u> <u>Effective Date</u>. This Ordinance shall take effect immediately and shall be published in the official newspaper of the City.
